### **Prize Draw Terms and Conditions**

- 1. Survey participants must be aged 18 years or over
- 2. Entry to the prize draw is only open to survey participants who reside within Australia. Australian Indigenous Health*InfoNet* staff and their immediate families are ineligible to enter.
- 3. The survey and associated prize draw close at 11.59pm AWST on 22nd of August, 2022.
- 4. Entrants in the prize draw must complete the survey and entry form during the survey period (26th of July, 2022 to 22nd of August, 2022)
- 5. Entrants must provide a valid email address and/ or phone contact number at the completion of the survey.
- 6. Participants may only complete the survey and enter the prize draw once.
- 7. The prize draw will take place on 24th of August, 2022.
- 8. The winners will be chosen at random.
- 9. The winners be notified by email and/or phone within 24 hours of the draw.
- 10. In the event that a winner does not respond to contact within 14 days, a new winner will be drawn.
